

Trust Deed

Hereby we (Trustor (s), Tibet Geographical Cycling Expedition Group) trust Plateau Tours Adventures Co., Ltd as our Trustee for arranging the Tibet Namtso and Siling Tso Bicycle tour from 5th September to 24th September 2007, the arrangements and requirements we trusted are as follows:

1) Itinerary

2) Service Contents Trusted

- A. - B. Provide a Dongfeng Brand truck from 8th September to 24th September for carrying luggage, equipments and food;
- C. Provide the following or equivalent accommodations:
 - a. Lhasa: 3 nights with 4 rooms in Dhod Gu Hotel;
 - b. Amdo: 1 night in Guest House;
 - c. Damshung: 1 night with 4 rooms in Burma Hotel
- D. Provide all three daily meals (from 9th September to 22nd September is picnic);
- E. Provide 2 steel oxygen bottles, 1 camping tent/2p, 1 mattress/p.p, 1 cooking tent/group, interphones/p.p (including for guide, driver and cooks), lighting outfits for camping (camping light);
- F. Provide all necessary Tibet Travel Permits and Particular District Permissions;
- G. Provide following sightseeing admission tickets:
Potala Palace, Jokhang Temple, Namtso, Norblingka Summer Palace, Yampachen
- F. Provide a Tibetan English-speaking tour guide;

- H. Provide a cook with an assistant through out the trip;
 - I. Provide whole set of cookers and dishwares;
 - J. Provide two China-made mountain bicycles for use in Tibet.
- 3) Tour fare
- According to the above itinerary and service contents, the cost based on 8 pax basis is:
- A. Tour Fare: 2,100USD/p.p * 8 persons = 16,800USD;
 - B. Total payment: 16,800USD.
- 4) Price Includes and Excludes
- The Price Includes:
- A. All private transfers as identified;
 - B. Truck transfers as identified;
 - C. All accommodations (including camping);
 - D. All three daily meals (including picnics);
 - E. Tibet Travel Permits and Particular District Permissions;
 - F. Sightseeing admission tickets as specified;
 - E. An English speaking guide;
 - G. A cook with an assistant;
 - H. All equipments as specified (including two bicycles provided by us);
 - I. Service fee for Trustee.
- The Price Excludes:
- A. Bicycles and fittings, repairing;
 - B. Personal equipments for biking;
 - C. Bedding (mainly are sleeping bags) for camping;
 - D. Insurance (mainly are Life Insurances, Travel Insurance and Accident Insurances);
 - E. Costs in Beijing;
 - F. Beijing/Lhasa/Beijing round way air tickets (including taxes);
 - G. Bicycle air transfers cost;
 - H. Tips for the local guide and driver;
 - I. International air fare and taxes;
 - J. Chinese Visa;
 - K. Personal expenses and other cost not specified in the above "Price Includes" section.
- 5) Payment
- The full payment shall be settled down before 5th September 2007 by cable transfer after the Trustor signed the contract. The transfer charge and all bank's charges is on Trustor's own (bank details attached below). The trip only be operated as the Trustor's payment arrival.
- 6) Indications
- A. This trust deed will be effective as signed by both Trustor and Trustee who will hold one of two trust deeds accordingly which has the same legal effect. If Trustor will cancel this trip, Trustor shall notice the Trustee by the written email or fax. The payment is non-refundable if the client makes cancellation of the tour. For any

changes after the contract signed, any extra charges caused by Trustors' changes will be added, as air cancellation fee, hotel cancellation penalty, etc. Any unused portion is neither refundable nor exchangeable.

- B. Due to complicated road conditions, especially around Namtso Lake areas, if there is landslide by heavy rains and caused truck can not drive ahead, Trustor agree to use local yaks or horses to carry luggage and equipments instead of the truck, while the truck makes detour and drive ahead before the blocked place where pick up the group and continue the trip. The costs caused and added will be afforded by the Trustee.
- C. If there is any emergency rescue of Trustor(s) on the way, the costs will be afforded by the Trustor (s).
- D. No extra payment will not be charged without the Trustor (s)' confirmation unless the cost for "Price Excludes" section items.
